## Official Rules for the 2022-2023 First Hawaiian Bank Bill Pay To Win Campaign

- 2) **FHB Mobile App:** FHB will post a Sweepstakes banner in the FHB Mobile App upon commencement of the Promotion Period. For each of these activities that you successfully perform via the FHB Mobile App during the Promotion Period, you will receive one (1) Entry:
  - 1) Add and pay a new payee \$10 or more
  - 2) Activate a new eBill
  - 3) Setup a new recurring or AutoPay payment
  - 4) Add and complete an inbound transfer from a new external account

Any Entry(ies) successfully submitted using these methods via the FHB Mobile App will be included in the drawing that will be held at the end of the Promotion Period. There is no limit on the number of Entries that can be submitted via this method.

3) **Entry by Mail:** To enter by mail, submit a handwritten 3"x5" card with your full name, complete mailing address, telephone number, and email address (if available) and mail it in a sealed, stamped #10 envelope addressed to: 2022-2023 First Hawaiian Bank Bill Pay to Win, Attn: First Hawaiian Bank — Marketing Communications Division, P.O.
